

AWARD CONDITIONS - 2026

Chancellor's Excellence Scholarship

Value

The scholarship will have a maximum value of:

- \$24 000 (32-unit degree), or
- \$18 000 (24-unit degree).

Plus an optional Study Abroad package with a maximum value of \$5000.

The scholarship will be paid as a stipend per study unit, per study period.

Eligibility

Recipient must:

- · be a domestic student currently residing in Australia
- have completed Year 12 in 2025
- · have an unadjusted ATAR of 97.00 or above
- have placed UniSQ as their 1st preference on their QTAC application
- be a commencing student
- be intending to enrol full-time at UniSQ in a bachelor's degree program prior to 25 September 2026.

Conditions

- The duration of the scholarship is for a maximum (not inclusive of any Leave of Absence) of:
 - o 6 years (32-unit degree), or
 - o 4 years (24-unit degree).
- The scholarship will be forfeited if the recipient:
 - o fails to continue to meet the eligibility criteria for the duration of the scholarship
 - does not enrol and complete a minimum of 6 study units for any full academic year for the duration of the scholarship, unless exceptional circumstances prevent studying a minimum of 6 study units (refer to the **Study Load Requirements** below for variations based on the 2026 study period commencements)
 - o defers their program of study any later than Trimester 3 2026
 - o takes more than 12 months total Leave of Absence
 - if a recipient takes leave for one trimester in an academic year, they must complete a minimum of 4 study units across the remaining two trimesters.
 - if taking leave for two trimesters in an academic year, they must complete at least 2 study units in the remaining trimester.
 - o withdraws from study at UniSQ
 - o fails to maintain a Grade Point Average (GPA) of at least 5.5.



AWARD CONDITIONS - 2026

- If the recipient undertakes cross-institutional studies, it is their responsibility to provide the Scholarships Office, via email study@unisq.edu.au immediately after census date, with evidence of:
 - o confirmation of enrolment in the second institution (post census date); and
 - o approval to undertake the study unit/s from the appropriate UniSQ school.
- UniSQ reserves the right to alter the conditions of the scholarship.

Study Load Requirements

For recipients commencing at UniSQ in Trimester 1 2026:

• be enrolled full-time (minimum 6 study units) across the academic year, each year for the duration of the scholarship.

For recipients commencing at UniSQ in Trimester 2 2026:

• be enrolled full-time (minimum 3 study units) across Trimesters 2 and 3 2026; and then continue full-time enrolment (minimum 6 study units) across the academic year, each year for the duration of the scholarship.

For recipients commencing at UniSQ in Trimester 3 2026:

• be enrolled full-time (minimum 2 study units) in Trimester 3 2026; and then continue full-time enrolment (minimum 6 study units) across the academic year, each year for the duration of the scholarship.

*Please be mindful of program enrolment restrictions. We highly encourage recipients to follow the program's recommended enrolment pattern and enrol for the full year at the commencement of each academic year.

Payment

- Payments are made approximately 4 weeks after the census date in Trimesters 1, 2 and 3 (as applicable).
- Payments will be credited to the recipient's bank account each year, for the duration of the scholarship, as follows:
 - o Trimesters 1, 2 and 3 (as applicable) \$750 per study unit, per study period.
- The scholarship will be paid for cross-institutional study units undertaken if approval is granted from the appropriate UniSQ school.
- Payment of subsequent instalments will be subject to satisfactory progress in the recipient's study program. In the event the recipient does not continue to meet the scholarship's eligibility criteria and conditions, they may be required to show cause why the scholarship should not be cancelled.



AWARD CONDITIONS - 2026

Optional Overseas Study Package

- Funding to undertake an overseas study program to a maximum value of \$5000¹ by UniSQ.
- Receipt of this funding is subject to:
 - o a successful application to study an approved² overseas study program
 - o student must have completed a minimum of 8 study units
 - students participating in a short-term experience must provide an itinerary detailing associated costs of the experience, and up to three receipts³
 - Semester exchange programs are automatically approved for the full \$5000 funding.

¹The value of the funding provided to the student is dependent on the total relevant costs outlined in the student's itinerary.

²For an overseas study program to be approved, written confirmation must be received by the student's relevant Program Director confirming that the overseas study program will result in credit (either for a full unit or for specific components of the unit such as practical classes, professional experience or individual assessment/s) towards the student's program.

³Student must provide up to three receipts for experience costs, at a value of approximately one third of the total funding request (e.g., airfares, accommodation, conference/program fees). Receipts can be provided either at the time of the funding request or after the student has paid for upfront experience costs, but must be provided prior to departure.

Important Information

- While not a requirement to be approved for an overseas study program, students do require at least 1 study unit remaining in their program after completion of the overseas study program to be considered for additional travel support via an application for the OS-HELP loan.
- If the student chooses to forego the OS-HELP loan, the final unit of the student's program prior to graduation can be awarded as credit based on the Program Director-approved overseas study program.
